The Employer agrees to use its reasonable endeavours to provide the following assistance to the Contractor to:

- Bring the Employer side together and ensure that Stakeholders are fully engaged in the process.
- · Attend project launch meeting.
- Discuss insurance, bond, parent company guarantee (PCG), warranty requirements.
- Prepare the health and safety plan and support provision of preconstruction information.
- · Attend project meetings as required.
- Arrange for payment for Preconstruction Activities.
- Sign off Gateway Reports.
- Appoint a Principal Designer (if not already done).

The Employer shall pay for such costs properly and reasonably incurred by the Contractor during the Preconstruction Stage provided that they have been incurred in accordance with the Agreed Scope and the terms of this Preconstruction Order and set out below. The Employer shall pay all such agreed costs on a monthly basis, in all cases within 14 days of receipt of a valid invoice by the Contractor.

Following completion of the Preconstruction Stage, the Employer may, at its sole discretion, decide to enter into a Delivery Agreement in respect of the design and/or construction stage of the Project.
